If copies not received by the actual billing date of next fiscal year exemption will be removed.

Ms. Nichols attended the meeting as she had seen her application on the board meeting agenda and wished to be present when her application was presented to the board. Ms. Nichols had contacted member Cynthia Richard in regards to her residential exemption being removed. At which time Mrs. Richard informed Ms. Nichols the issue would have to be conducted at a board meeting and that it was not able to be placed on the agenda. Unknown to Mrs. Richard that Ms. Nichols had submitted a residential exemption application to the office that day. Administrative Secretary Meghan Montesion had placed the application on the agenda prior to the posting deadline. Ms. Nichols did not return the statement of residency and the requested supporting documentation. The Board of Assessors informed her that once the exemption application deadline of April 1, 2108 has passed that the Board no longer had jurisdiction in which to act on the exemption. It was further explained that the Board had published information about the request for the statement of residency in which to continue to benefit from the exemption for fiscal 2018. In addition to the mailing of reminders to all parcels had not returned the requested documentation. It was stated by the Assistant Assessor that the residential exemption is always printed on the actual tax bill. It is the taxpayer's responsibility that they review the tax bill in which to determine if they would like to appeal or apply for an exemption. That the taxpayer had adequate time in which to review the tax bill, reach out to the office and apply for the residential exemption.
