Member Dandridge suggested making a policy to do an extension until February 1st for all established exempt organizations that have been receiving the exemption over the years.

Principal Assessor explained that the office sends the 3ABC forms in December, then emails a reminder, and then does a follow-up call a week before the due date of March 1<sup>st</sup>. She suggested the policy be on a case-by-case basis, rather than a blanket policy.

Member Dandridge believes it should be a general consistent policy as an additional effort on the Board's side.

Member Richard asked if the extension needs to be initiated by the organization.

Principal Assessor answered that the organization needs to request an extension but there is a variance where the board can initiate the extension up to the first due date of the actual tax bills.

Member Richard stated she would like to see the Appellate Tax Board's decision before deciding on Member Dandridge's suggestion. Members decided to table the discussion.
