



## 2016 APPLICATION FOR 24-HOUR PARKING STICKERS (SPRING STREET AREA)

*Spring Street from Pine to Main, Clough Lane, Franklin Street from Spring to Greenwood Avenue, Center Street from William to Pine, Church Street from William to Franklin, William Street from Woodlawn to Look and the business district of Main Street.*

Stickers are only available to the residents of the above listed streets and only for cars registered in Tisbury, Massachusetts at the address applied for. DURING A SNOW PARKING BAN YOU MUST REMOVE YOUR CAR FROM ALL TISBURY STREETS. PLEASE USE PARK & RIDE LOT, FREE FOR 6 DAYS.

I hereby make application for permit(s) to park in the Spring Street area. I understand the following: The cost is \$15.00 per permit, per calendar year, with a limit of 3 per family unit. Residents who are renting must show a lease as proof of eligibility. The permit is only to be used to park as close to my residence as possible. You may not park on Main St., Union St. or the Water St. and Union St. lots. The permit is not to be used for extended shopping, downtown business, or off-Island travel. Stickers must be placed on the driver's side toward the rear of the vehicle. Permit holders must follow MA State Law and not park on any street for more than 72 hours. All stickers expire 12/31. Violators will be ticketed and/or towed and may lose parking privileges.
