Action: Parking Committee to review the Park & Ride Regulations <u>Motion: Approve the commercial trailer request at the Park & Ride until October 15, 2016. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions</u>

PUBLIC HEARING(s)

6:00PM Lodging House License, Platinum Pebble, LLC, dba Nobnocket Boutique Inn; Simon Hunton (Continued from May 17, 2016) Discussion regarding the License took place. No public comment. <u>Motion: Close Public Hearing. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions. Motion: Approve the license. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions</u>

DISCUSSION SESSION

Murdick's Run the Chop Challenge: Annual Road Race July 4th, 2016 Announcement was read regarding the 15th Annual Event. *Motion: Approve the event. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions*

Cooperation Agreement regarding payment in lieu of taxes with the Island Housing Trust for 6 Water Street was discussed. Jay Grande suggested some term limits to the Pilot Agreement. <u>Motion:</u> Approve the Pilot Agreement for 25 years effective of end date of mortgage. This approval and language is subject to Town Council input. Vote: unanimously: 2 ayes, 0 nays, 1 abstentions

PUBLIC HEARING(s) 6:15PM Proposed Rate Increases: Landfill Fees for Local Drop-Off (LDO) at High Point Lane to become effective July 1, 2016. Discussion took place regarding recommendations from the consultant. Jay Grande noted that the LDO can now provide a full range of services with modest increases. A senior citizen rate was now established. Public Comment: Harriet Barrows inquired about the curbside recycling. Melinda discussed the Town contract for curbside collection aided in providing service to areas that were normally not able to obtain that type of service due to location. The Town contracts with Bruno's and the rates are set for curbside trash pickup. The cost increase from Bruno's is to maintain service. Discussion took place regarding town revenue losses, private options, commercial dump trucks and residential stickers. Motion: Close Public Hearing. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions Motion: Approve the suggested fees with Ray and Jay rework the grass leaves with dump truck reviewing the definition of a commercial dump truck effective July 1st, 2016. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions

PUBLIC HEARING(s) 6:30PM Shellfish Regulations Amendments proposed by the Shellfish Advisory Committee: Discussion surrounding changes requested at the May 17th meeting. The "Teeth Regulations" were reviewed by Town Council and the committee. Public Comment: Packer stated that we have no regulations saying no to Bar Drags. Someone questioned the use of this language in Shellfish Regulations in the first place. Tilton suggested that we review other Towns Regulations. It was discussed to revisit Bar Drags another time. Discussion for establishment of area behind Wind's Up. Discussion took place regarding Family Permits and Commercial vs. Family/Recreational being hard to track. The Selectmen asked Danielle to ask the Environmental police particulars regarding monitoring the sale recreational shellfish/commercial. Motion: Close Public Hearing. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions Motion: Approve paragraph 13. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions Motion: Approve Family Shellfish Permit paragraph. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions

DISCUSSION SESSION

Cheryl Doble discussed a request regarding the Housing Production Plan proposal; <u>Motion:</u> support the request and sign the joint proposal. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions

Complete Streets: Ray and Jay stated the plan is to have the Selectmen adopt policy, create a prioritization plan including safety and accessibility, and plan on amount per year to implement. The State would need to review policy on all roads. The letter of intent is to develop and access funding. <u>Motion:</u> Sign the letter of intent. Vote: unanimously: 3 ayes. 0 nays. 0 abstentions

Proposed Nitrogen Regulations: Maura Valley and Jeff Pratt from the Board of Health came to announce hearing dates on this topic in an effort to reach out to the public.

Ride Sharing Services: Taxi Regulations will be discussed on June 21st.

Non-Water dependent uses or vessels in harbor-Moratorium/Update: Discussion occurred on floating structures, house boats and commercial uses. Tristan Israel discussed a commercial dock that is attached to an accessory structure and that issue needs review along with a barge to dock issue. Public Discussion occurred stating that the vessel paid excise tax as a vessel and was not connected to the dock it was anchored. The Selectmen requested that fact finding take place regarding these topics and regulations/guidelines be reviewed. Town Council needs to review regulations and guidelines for the permitting process. <u>Motion:</u> Hold public hearing on July 19. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions

MSBA Feasibility Study/ Feasibility Study Agreement-Tisbury Elementary School: <u>Motion: Approve the Study/Agreement. Vote: unanimously: 3 ayes, 0 nays, 0 abstentions</u>

Athletic Field Proposal Request for referral as DRI to Martha's Vineyard Commission (MVC): The Selectmen were asked to consider sending this proposal to the MVC. Public Comment: A lengthy discussion occurred with various speakers about the process. Discussion on rubber vs. organic fill took place. Larry stated that the School Committee represents a regional body and the vote was to accept it. He has reviewed the videos and literature and found that it was a very thorough process. He does not wish to send this to the MVC. Tristan stated that procedurally he was not sure we could send it to the MVC as there is no open permit and the MVC cannot accept it without an open permit. Melinda felt that the permitting process has not yet occurred and that process deserved time to evolve. Motion: Take no action on this matter at this time. Vote: unanimously: 3 ayes, 0 nays, 0
