CALL TO ORDER

The meeting was called to order at 4:07 PM. (Discussions have been summarized and grouped for clarity and brevity.)

NEW BUSINESS

• The Resource, Inc. Melissa Vincent was requesting, through the Tisbury Municipal Housing Trust (TMHT), funding to support the Housing Rehabilitation Program. Two applicants that were Tisbury residents, could not be helped because of the financial income limitations on the existing programs. Ms. Vincent created a program six years ago using Community Preservation Committee (CPC) funding; Oak Bluffs and Edgartown have funded 28 projects with this program, serving people within the 81 - 99% median income levels; Tisbury has not opted into this program.

This money, Preserving Affordability with Loan Support (PALS), is deed restricted for 15 years; the rehabilitation funding would be returned in full if the property was sold before then. The cost per project was between \$30,000 and \$40,000 based on increased labor and material costs; Ms. Vincent suggested this be as a pilot to test this program for Tisbury residents. She said it was challenging to come to the Town of Tisbury, but the people she was serving were in true need and didn't believe the client/s could wait another year. Approved funding would first support the roof replacement; remaining funds would go to the second applicant.

Chair Dan Seidman was uncertain if there was a limit on the TMHT that could prevent this to occur; he would follow-up as well as find out the current balance.

Discussion:

- Members were concerned about the 15 year period, however they were all in agreement the goal was
 to keep people on the Island.
- TMHT was a combination of CPC funds and other Town funds; the accountant would have the breakdown. CPC was interpreted differently in Tisbury than other towns.
- A suggestion to use \$50,000 that was separated out at Town meeting from CPC could be used now, and to place a warrant article for the Annual Town Meeting next year.

- It would take too much time to build the fund, use the available funds now to apply to this program; some said to hold off and let the fund build.
