TOWN ADMINISTRATOR REPORT

Tisbury Waterways Inc. Donation

Town Administrator informed the Board Members of the donation Town received from Tisbury Waterways Inc. to support monitoring enforcement for Harbormaster and Shellfish Departments.

Member Israel motioned to accept Tisbury Waterways Inc. Donation. Member Loberg seconded the motion.

The motion was unanimously approved.

Public Hearing Notice for NSTAR Electric Company

Town Administrator presented Public Hearing Notice for NSTAR Electric Company. The hearing is connected to proposed increase of electric rates. All materials submitted for that hearing are available for public review at the Vineyard Haven Library. Member Israel offered his candidacy to represent Tisbury Board of Selectmen at the hearing on August 2nd, 2017.

Complete Streets

Town Administrator reported that the Board of Selectmen Office is waiting for a written confirmation of the grant we expecting to receive for a Complete Streets Project in the amount that was requested \$371,000.

To accommodate request from Daedalus & T2 to present Tisbury School Project earlier than originally scheduled, Board of Selectmen moved to postpone Continued Public Hearing to discuss and consider proposed amendments to the Tisbury Moped Regulations till 5:40 PM.

5:00 PM Continued Public Hearing to discuss and consider proposed amendments to the Tisbury Moped Regulations

Town Administrator would like to add Paragraph 18 to the list proposed changes to the Tisbury Moped Regulations. Said paragraph states that Board of Selectmen and their designees: Police Chief and Building Inspector shall administer and enforce the provisions of moped by-law and moped regulations. Police Chief and Building Inspector shall inspect each agency for compliance prior to annual license renewal and report to the Board of Selectmen. In addition Police Department will perform periodic inspections. This paragraph would allow inspection process to be more structured. Member Israel would like to add language to the paragraph that clear instructs Police Department and Building Inspector to report the results of performed inspections to the Town Administrator. Member Loberg spoke in support of Member Israel's suggestion to add reporting guidelines to the proposed paragraph.

Member Loberg motioned to add proposed changes to the Tisbury Moped Regulations. Member Israel seconded the motion.

The motion was unanimously approved.

Town Administrator noted that changes to the penalty fees will require a Town Meeting, so they will remain the same at the present time.

Member Loberg motioned to approve the revised Tisbury Moped Regulations. Member Israel seconded the motion.

Motion was unanimously approved.

5:45 PM Public hearing to consider an application for an All Alcohol License for exercise at Mikado Asian Bistro, 76 Main Street, Tisbury.

Mr. Yu represented Mikado Asian Bistro. He once more thanked Board of Selectmen for holding a special meeting past Friday to review his application for Common Victuallers License. Since restaurant opened its been very busy and management keeps receiving positive feedback from its customers. Town Administrator mentioned that the office is still waiting to receive Worker's Compensation Policy Declaration Page from Mr. Yu and if Board will move in favor of this application, he would like to request that approval to be conditional. Member Gomez informed applicant that they are not allowed to have any alcohol on premises until actual license is issued. Mr. Yu stated that he is in contact with Martha's Vineyard Insurance and they are currently working on coverage for his business. Member Israel asked if there is a TIPS certified employee on the premises at the time of service. Mr. Yu confirmed.

Member Israel motioned to approve an application for an All Alcohol License for exercise at
Asian Bistro, 76 Main Street, Tisbury. Member Loberg seconded the motion.

Martha's Vineyard Museum Complaint

Board of Selectmen received another complaint regarding the event that was held on the Martha's Vineyard Museum Property. There is a tendency of the events that rent the space, causing a disturbance among Museum's abutters. Town Administrator noted that there is an existing memorandum of understanding between the Town and MV Museum regarding the event use of their property.

Member Israel motioned to schedule a meeting with Marth's Vineyard Museum to review existing MOU and address the issues connected to event use of their space. Member Loberg seconded the motion. The motion was unanimously approved.

Harbormaster reported to the Board regarding the boat fire on the Lagoon Pond. He agreed with Fire Chief and complemented outstanding work of every department that arrived at the scene of accident. In his report he described the process of salvaging ship wrecks from the Lagoon.
