New Accessory Apartment	\$500.00
New Garage/Barn/Shed/Accessory Structure	.65¢ per sq. ft. – minimum \$300.00
Additions	.75¢ per sq. ft. – minimum \$200.00
Alterations/Repairs	.75¢ per sq. ft. – minimum \$150.00

## Commercial Construction Permit Fees

New Construction	.85¢ per sq. ft. – minimum \$850.00
Additions	.85¢ per sq. ft. – minimum \$425.00
Alterations/Repairs	.85¢ per sq. ft. – minimum \$250.00
Change of Occupancy Classification	\$150.00

Minor Work Permit Includes: Roofing only, siding only, replacement windows & doors (no structural change), deck repairs (no expansion of footprint) solar, weatherization, ductless air source heat pumps, and retaining walls.

Square footage calculations are based on gross square footage including decks and is measured from the outside of the building when exterior work is involved, and from the interior of the walls if only interior work is involved. The Building Inspector shall make the final permit fee determination in their sole discretion in accordance with 780 CMR.
