**Discussion** 

Approval of Minutes of Meetings on 5/18/21

- C. Wallis moved; G Hokanson seconded.
- Motion approved 5-0
- 1. Meeting with Spring Building Committee
  - C Wallis reported that she and G. Hokanson met with the Tashmoo Spring Building Management Committee and S. Codding from DPW. The management committee voted to write a letter to the Select Board stating that they did not support Mr. Adler's request to lease the Spring Building for the development of a restaurant. The management committee noted that the building had been preserved using public funding and that it has always been intended for public use. They also noted that the building is heavily used and rented for events almost every weekend this summer. The fees collected go to the DPW for the maintenance of the building. C. Wallis reported that the management committee would be interested in meeting with the Open Space and Recreation Committee to discuss ideas for use of the site and its preservation from future development.
  - G. Hokanson asked if we should write our own letter expressing our view on Mr. Adler's request
    and include our interest in protecting the park. He also reported on discussion regarding the use
    of the former Water Department office for housing. The Spring Building Management
    Committee is not in favor of that use. According to S. Codding, the building is in need of
    renovation and is not suitable for housing at this time.
  - C Doble said that she would contact L. Wells, the head of the management committee to see if she would like our committee to write a letter to the Select Board.

## 2. Update on Community Preservation warrants

• C Doble reported that if there were questions regarding any of our project at town meeting that C Wallis would answer questions and provide any necessary explanations.

#### 3. Owen Park

• C Doble reported that Ben Kelly should have the projection analysis for the Bandstand completed in a week or two.

#### 4. Story Mapping

G Hokanson reported that C. Seidel had added a yellow directional line to the map and that he
had added text to guide navigation along the route. He also added a VTA link if people want to
take the bus to a point of interest or back to town rather than walk the whole route. G
Hokanson noted that the overview map included in the StoryMap was not a great directional
guide and that the map guidance within the MV Trails app will be better.

#### 5. Review of Year Two Committee Work

- C Doble shared C Wallis's personal work outline for the next three months with the committee.
   She suggested that we all try to complete a similar outline for the tasks that we have volunteered to take on. H. Stephenson said that he was going to set up a meeting with J.
   Burrows to talk about their shared waterfront tasks. C. Doble suggested that J Burrows reach out to Bill Veno at the MVC to learn about their work on bike routes. She also suggested that he meet with regular bike riders to understand the streets that they typically use to get around town
- G. Hokanson asked about contacting town Counsel to have him review the Land Bank MOU. C. Doble said that she would contact J. Grande about this.

### 6. Outreach

C. Doble noted that she had not made much progress with community outreach. She suggested that we need a strategy and help. H. Stephenson asked how the School Building Committee was doing this. G. Hokanson felt that it was important to let the community know what we are doing and can provide input. He reminded the committee that George Brennan was interested in writing an article on the story mapping for the MV Times. Committee members proposed other ideas including, scheduled park events and activities, and the Vision Forum. C. Doble said that she was going to get some training on the Town website in June.

#### 7. Inter-active map

• G. Hokanson shared an interactive map created by C. Seidel that located parks and trail heads and delineated circle with a ¼ mile radius at each of the points. He said that the map will be accessible to us online.
