CALL MEETING TO ORDER

Review and approve amendments to COVID-19 Shelter in Place Order & COVID-19 Construction & Jobsite Order

Member Loberg read out the section of the Construction Moratorium as revised: "Effective Wednesday, March 25, 2020 the Town is suspending all regular construction activity in Tisbury, including but not limited to all work authorized by building permits, electrical permits, plumbing and gas permits, and street opening permits, as well as landscaping work and painting work . Upon issuance of this order, all active construction work shall be stopped and any open construction sites shall be secured to prevent unauthorized entry, damage to equipment and/or work-in-progress, and to protect public safety. Operators shall employ the necessary crews and labor to complete the work necessary to secure their sites by 5:00 p.m. on Wednesday, March 25, 2020. After that time only skeleton crews of not more than 2 persons will be permitted to enter construction sites for the remainder of the moratorium and such entry shall be limited to emergency work as defined below. These people must be educated on social distancing and safety procedures intended to prevent the spread of Covid-19."

Board of Health has reviewed and approved this revision earlier in the morning. Said revision will prohibit any work rather than emergency work as described in the moratorium.

Member Kristal motioned to approve construction moratorium as revised. Member Rogers seconded the motion. Roll Call Vote: Melinda Loberg-Aye; James Rogers-Aye; Jeff Kristal-Aye. The motion was approved.

Richard Saltzberg, MV Times asked how this moratorium will apply to vegetable gardening and how it would effect Mr. Barnes's property?

Ross Seavy answered the question stating that moratorium would not affect individuals trying to help their friends/relatives to maintain a vegetable garden. As to the Mr. Barnes's property any work permitted will be in accordance with the approved moratorium.


