The proposed route is seasonal, offering service from the Friday before Memorial Day through Labor Day with a peak schedule from Father's Day weekend through Labor Day. Waterways Committee reviewed this request and recommended that Select Board Members approve harbor use permit for Falmouth Water Transportation Inc.
