MEETING CALLED TO ORDER AT 5:00 PM

TOWN ADMINISTRATOR REPORT

Mass DOT Beach Road Project Update

Town Administrator informed Select Board that the state requested approval of continued work at the Beach Road until June 25th. Member Gomez stated that he is not against the request however he would love to see the road swept and lines painted. Member Kristal spoke against the request stating potential impact on the business located along the Beach Road. Member Rogers also was concerned with potential impacts but asked that road sweeping, and painting of lines be done regardless. Board Members suggested that night-work may be more acceptable. Town Administrator concluded that more specificity is needed regarding the extend of continued work and the potential impact on local businesses. Town Administrator will confer with MassDOT regarding concerns raised by the Board.

Resolution and Bond Vote for the \$893,000 USDA Sewer Loan

Jon Snyder stated that due to the small delay in submitting of the bond related paperwork Bond Counsel requested the Board to re-vote the resolution with updated dates.

<u>Declarations & Orders in Response to Covid-19:</u>

- Town Wide Events, Memorial Day Parade
 In light of recent revocation of the COVID-19 restrictions, Veterans Agent requested Board's approval of the Memorial Day Parade on May 31st, 2021. The parade will begin at American Legion Hall at 10:30 AM.
 - Member Kristal motioned to approve Memorial Day parade. Member Gomez seconded the motion. Roll Call Vote: Gomez Aye; Rogers Aye; Kristal Aye. The motion was unanimously approved. Member Kristal suggested getting in touch with street fair organizers to discuss potential new dates for the street fair.
