Geoghan Coogan stated he has served Tisbury previously on the Zoning Board of Appeals and Select Board. He has two girls freshmen at the High School and a boy who is graduating. Mr. Coogan has a lot of people and communication skills to offer back to the community.

Ben Robinson stated that he finds municipal projects interesting and lacking at points. He is especially interested in this one as probably the largest community project in our time. He grew up in a family of builders and have been practicing architect for years.

James Moffatt explained he has not been involved in much community work because he has a young family. He has his own architecture firm. Mr. Moffatt had a grad school project that inspired him for this project. He could help contribute with his knowledge and experience and make something the community will be proud of.

Chair Cutrer asked how does everybody feel about the time commitment?

Ms. Rizzo responded that she lives here full time, is retired and flexible with her time.

Mr. Coogan responded that he can set his own schedule. He anticipates a long commitment that will intensify as the project progresses.

Mr. Robinson responded that he basically lives at his office and even if he is not appointed will follow the project closely.

Mr. Moffatt responded he is aware of the large commitment. He also has a flexible schedule.
