TOWN OF TISBURY PUBLIC HEARING ON TISBURY WATERWAYS REGULATIONS

The Tisbury Board of Selectmen will hold a public hearing to continue the discussion and consideration of amendments to the Tisbury Waterways Regulations establishing rules for types of vessels permitted, types of permitted water dependent and non-water dependent primary and secondary uses, and licensing / permitting and use restrictions, including the prohibition of non-water dependent uses in waterways and barges in the Inner Harbor mooring area; designation of waterfront uses requiring a land-based access point; and specification of eligible waterways for mooring, anchorage and launching/landing of non-traditional vessels; and to consider adoption of a temporary moratorium of up to 18 months to prohibit the establishment of any new non-water dependent use or vessel in Tisbury Waterways not currently addressed by the Waterways Regulations so as to provide the Town time to develop comprehensive regulations to address non-water dependent uses and vessels.
