# **HEALTH AGENT REPORT**

# Targeted Wastewater Management Plan (TWMP)

The plan and two SRF (State Revolving Fund) applications have been submitted to the state, one for just under \$1MM for multiple enhanced I/A system installations and another for the cluster system near the Lake Street tennis courts. Michael Loberg, Scott Horsley, Adam Turner, and Ms. Valley will meet on Thursday with the West Tisbury BOH to discuss their involvement in the TWMP; approximately 25% of the Tashmoo Watershed properties are within their town limits.

# SECTION 5. INSTALLATION OF ENHANCED DE-NITRIFICATION TECHNOLOGY

- 5.1 Upon the occurrence of a trigger as set out in section 5.2 (and subject to sections 5.4, 5.5 and 5.6), the Board of Health will only issue a permit for a proposed new wastewater treatment system and/or any system upgrade for a **Property** in a **Watershed District** provided:
  - a) the application provides for an Enhanced De-Nitrification Technology; and
  - b) all other conditions for the issuance of a permit are met.
- 5.2 The following situations are "triggers" for the purposes of section 5.1:
  - a) a new wastewater treatment system is required to serve a **Property** (i.e., new construction);
  - b) at the time of replacement, upgrade or relocation of a property's existing wastewater treatment system;
  - c) additional development on the **Property** or a change in use or in intensity of use (or potential use) which would increase wastewater Nitrogen discharge beyond the Board of Health approved system capacity irrespective of whether the existing wastewater treatment system has excess sanitation capacity<sup>1</sup>;
  - d) at the time that a **Property** is transferred to another owner.

#### ARPA funding applications

The BOH office has received six inquiries, of which one application submission appears to qualify for the funding. We will review recent and future Disposal Works Application approvals for possible qualification.
