Town Administrator Report for Select Board Meeting Wednesday, March 8, 2023

Vineyard Wind, Marine Terminal and 69 Beach Road Update

The operations and maintenance support facility at 69 Beach Rd will commence construction mobilization this week. Dellbrook Contractors will start general site cleanup, construction trailer delivery and site perimeter construction safety fencing will be installed. Lawrence Lynch will also start removing the remaining asphalt, installing erosion control measures and bring in fill for initial site work.

The Vineyard Wind Marine Terminal continues with the construction of the Tisbury Marine Terminal bulkhead side. Mobilization of the marine assets for the start of construction for the Vineyard Wind section is currently scheduled for March 13th. A pre-construction meeting with town staff is scheduled for Thursday morning, March 9, 2023.

Beach Road Weekend Music Festival Update

A meeting with public safety officials was held last Friday to review the Emergency Action Plan (EAP). The preliminary site schedule was reviewed. The logistics and public safety personnel requirements for the event were discussed. A civilian point of contact will be provided during the event to field incoming questions and concerns during the festival setup, event and breakdown that is employed by the town. Further, public safety officials will go through real world tabletop exercise to evaluate the submitted EAP and planning for the festival.

Coastal Zone Management Coastal Resiliency Grant Update

The project lead consultant is John Ramsey of Sustainable Coastal Solutions (SCS). The following work has been the focus of SCS efforts during February 2023:

- bi-weekly meetings;
- reached out to Leslie Fields from Woods Hole Group regarding efforts related to availability and quality of sediments planned to be dredged from the harbor. Ms.
 Fields indicated that updated information was available, but have not received it to date;
- on February 10th, held a coordination Zoom meeting with the Barrett & Associates team who are performing the Master Plan for the Town;

- relative to upland drainage concerns, reached out to Horsley & Witten about information regarding the historic drainage ditch and possible Chapter 91 license running parallel to Lagoon Pond Road and Beach Road;
- reviewed the Draft Horsley & Witten report related to possible drainage plans within the Veterans Park watershed;
- attended the MassDOT Tisbury drainage meeting (January 30, 2023) that
 primarily focused on drainage recharge west of Vineyard Haven along State
 Road, and the issues related to the harbor outfall from Five Corners; and
- MassDOT (Pam Haznar) requested additional information regarding potential Town plans related to coastal resiliency.

A larger public meeting is scheduled end of March 2023. The Climate Committee with host the meeting with invite to Conservation, Water Resources, Tisbury Waterways, Inc., and others.
